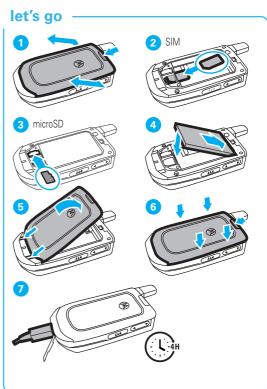

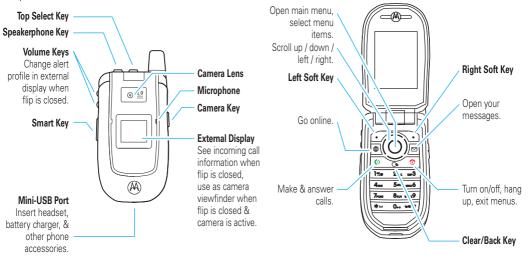

your phone

The first time you turn on your phone, it asks whether you want to store your phonebook Contacts on both your Phone & SIM Card, or on your SIM Card Only (once you select an option, you cannot change it). **Note:** Only the contact's name and phone number can be stored on the SIM card.

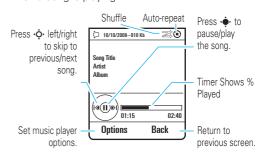

When a song is playing:



- To control the music player, press the center key ♠ to play or pause ►II, press ♠ left for previous ◄, or press ♠ right for next ►I.
 Hold ♠ left or right to rewind or fast forward.
- **To change the volume**, press the *volume keys* on the left side of your phone.
- To minimize the music player and leave the music playing, press ①. To reopen the minimized player, press ② up and select the song again. To stop the music, press ② twice.

Here are a few messaging basics to get you started:

read & reply to a message in the external display

(Network/subscription dependent feature) When the phone flip is closed and you receive a message, your phone plays an alert, and the external display shows New Message from X, where X is the sender's number or name.

To read and reply to the message in the external display:

- Press the volume keys on the side of your phone to scroll to **View**, then press the side select key to read the message.
- When you finish reading the message, press the side select key to close it.
- To answer the message, press the volume keys to scroll to Quick Reply, then press the side select key.

Rogers Music Player

Find it: • > • Rogers Music Player > song

To store **Rogers Music Player** files, use your computer to create a folder called "music" on your phone's memory card (not under the "mobile" folder). Then, drag and drop music files from the computer into the "music" folder on the memory card.

create and play a playlist

To create a playlist on your phone:

Enter a playlist name, then select the playlist and select Add Songs to add songs.

To play a playlist, highlight it under Playlists and press the *center key* • twice.

battery conservation tips

 - > 5 Seconds.
- Turn off the internal display screensaver:
 Press Settings > Phone Settings > Display Settings
 - > Screensaver > Off.
- Turn off Bluetooth® power when not in use: Press ♠ > ♠ Settings > Connections > Bluetooth, press Outions > Setup Bluetooth > Bluetooth Power > Off.

battery use & safety

IMPORTANT: HANDLE AND STORE BATTERIES PROPERLY TO AVOID INJURY OR DAMAGE. Most battery issues arise from improper handling of batteries, and particularly from the continued use of damaged batteries.

DON'Ts

- Don't disassemble, crush, puncture, shred, or otherwise attempt to change the form of your battery.
- Don't let the phone or battery come in contact with water. Water can get into the phone's circuits, leading to corrosion. If the phone and/or battery get wet, have then checked by your carrier or contact Motorola, even if they appear to be working properly.
- Don't allow the battery to touch metal objects. If metal objects, such as jewelry, stay in prolonged contact with the battery contact points, the battery could become yerv hot.
- Don't place your battery near a heat source. Excessive heat can damage the
 phone or the battery. High temperatures can cause the battery to swell, leak, or
 malfunction. Therefore:
- Do not dry a wet or damp battery with an appliance or heat source, such as a hair driver or microwave oven.
- · Avoid leaving your phone in your car in high temperatures.

- Do avoid dropping the battery or phone. Dropping these items, especially on a hard surface, can potentially cause damage.
- Do contact your service provider or Motorola if your phone or battery has been damaged from dropping or high temperatures.

- If there is no hologram, the battery is not a Motorola battery;
- If there is a hologram, replace the battery and retry charging it;

Specific Absorption Rate Data

This model wireless phone meets the government's requirements for exposure to radio waves.

Your wireless phone is a radio transmitter and receiver. It is designed and manufactured not to exceed limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission (FCC) of the U.S. Government and by the Canadian regulatory authorities. These limits are part of comprehensive guidelines and establish permitted levels of RF energy for the general population. The guidelines are based on standards that were developed by independent scientific organizations through periodic

and thorough evaluation of scientific studies. The standards include a substantial safety margin designed to assure the safety of all persons, regardless of age or health.

The exposure standard for wireless mobile phones employs a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by the FCC and by the Canadian regulatory authorities is 1.6 W/kg. ¹ Tests for SAR are conducted using standard operating positions accepted by the FCC and by Industry Canada with the phone transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the phone while operating can be well below the maximum value. This is because the phone is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station, the lower the power output.

Before a phone model is available for sale to the public in the U.S. and Canada, it must be tested and certified to the FCC and Industry Canada that it does not exceed the limit established by each government for safe exposure. The tests are performed in positions and locations (e.g., at the ear and worn on the body) reported to the FCC and available for review by Industry Canada. The highest SAR value for this model phone when tested for use at the ear is 1.32 W/kg, and when worn on the body, as described in this user guide, is 0.8 W/kg. The SAR value for this product in its data transmission mode (body-worn use) is 0.31 W/kg. (Body-worn measurements differ among phone models, depending upon available accessories and regulatory requirements).²

While there may be differences between the SAR levels of various phones and at various positions, they all meet the governmental requirements for safe exposure. Please note that improvements to this product model could cause differences in the SAR value for later products; in all cases, products are designed to be within the guidelines.

Safety and General Information

This section contains important information on the safe and efficient operation of vour mobile device. Read this information before using your mobile device.

Exposure to Radio Frequency (RF) Energy

Your mobile device contains a transmitter and receiver. When it is ON, it receives and transmits RF energy. When you communicate with your mobile device, the system handling your call controls the power level at which your mobile device transmits.

Your Motorola mobile device is designed to comply with local regulatory requirements in your country concerning exposure of human beings to RF energy.

Operational Precautions

For optimal mobile device performance, and to be sure that human exposure to RF energy does not exceed the guidelines set forth in the relevant standards, always follow these instructions and precautions.

Product Operation

When placing or receiving a phone call, hold your mobile device just like you would a landline phone.

If you war the mobile device on your body, always place the mobile device in a Motorola-supplied or approved clip, holder, holster, case, or body harness. If you do not use a body-worn accessory supplied or approved by Motorola, keep the mobile device and its antenna at least 2.5 centimeters (1 inch) from your body when transmitting.

T-Ratings: Phones rated T3 or T4 meet FCC requirements and are likely to be more usable with a hearing device's telecoil ("T Switch" or "Telephone Switch") than unrated phones. T4 is the better/higher of the two ratings. (Note that not all hearing devices have telecoils in them.)

Hearing devices may also be measured for immunity to this type of interference. Your hearing device manufacturer or hearing health professional may help you find results for your hearing device. The more immune your hearing aid is, the less likely you are to experience interference noise from mobile phones.

- Call roadside assistance or a special non-emergency wireless assistance number when necessary.
