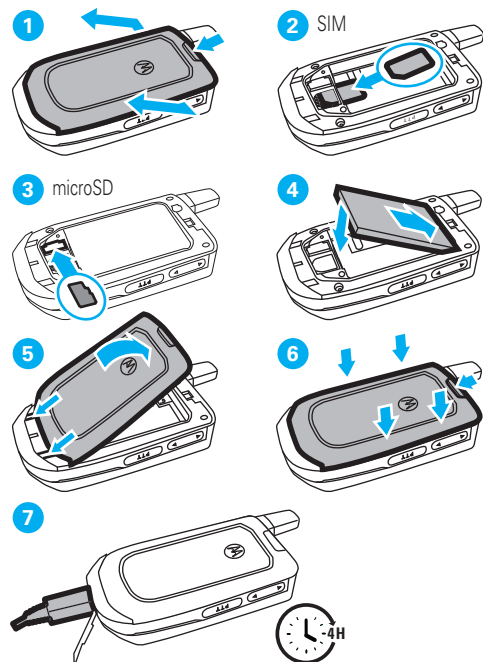

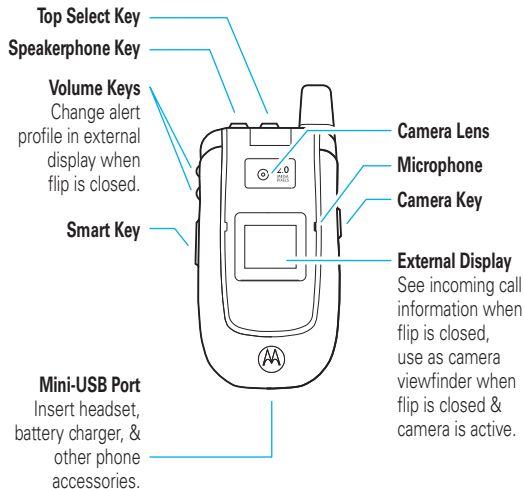

your phone

The first time you turn on your phone, it asks whether you want to store your phonebook **Contacts** on both your **Phone & SIM Card**, or on your **SIM Card Only** (once you select an option, you cannot change it). **Note:** Only the contact's name and phone number can be stored on the SIM card.



Tip: Press to open the main menu and select menu options. Press to delete letters or numbers, or to go back one menu.

basics

Here are a few essential basics:

turn phone on & off



Press and hold for a few seconds, or until the display turns on or off.

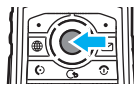
menu navigation



From the home screen, press to open the **Main Menu**.



Press up, down, left, or right to scroll to a menu feature.



Press to select the highlighted menu feature.

It's your phone, make it that way!

home screen shortcuts

(Network/subscription dependent feature) From the home screen, press up, down, left, or right as shortcuts to your favorite features. You can change the shortcuts to suit your needs.

To **change** navigation key shortcut icons in the home screen:

Find it: > Settings > Home Screen > Navikey Shortcuts > Up, Down, Left, or Right

Select a direction, then choose the feature you want to open when you press the navigation key in that direction.

To **show or hide** navigation key shortcut icons in the home screen:

Find it: > Settings > Home Screen > Navikey Shortcuts > Icon Display > Show or Hide


Note: You can press to select the features in the home screen even when the icons are hidden.

calls

Yes, your phone makes calls too!




make a call

Enter a phone number and press .




answer a call



When your phone rings or vibrates, open the phone flip or press  to answer.



end a call

To “hang up,” close the phone flip or press .

redial a number

- 1 From the home screen, press  to see a list of recently dialed calls.
- 2 Scroll to the number you want to call, and press .

music

When music is what you need...

load your songs from a computer



To copy music from your computer to your phone, you need the following:

- computer with music files in these formats:

music file formats	sampling rate
AAC+, Extended AAC+	up to 128 kbps
WMA	up to 160 kbps
MP3, AAC	up to 256 kbps

- microSD memory card
- USB data cable, or a computer that supports Bluetooth® connections.

Once you have these, connect your phone to a computer and load your songs. For more details, see your *User's Guide*.

contact list

Saving and calling your contacts is effortless.

store a phone number

You can store a phone number in your list of **Contacts**.

To store a phone number:

- 1 Enter a phone number in the home screen.
- 2 Press **Save**.
- 3 Enter a name for the phone number, and enter other information as desired.
- 4 Press **Save** to store the contact.

call a stored phone number

To call a number stored in your contact list:

Find it:  >  **Contacts**

- 1 Scroll to the contact.

Shortcut: In the contact list, press keypad keys to enter the first letters of the contact you want. Press  to go to the contact.

wallpaper

Change the background wallpaper image in the home screen:

Find it:  >  **Settings** > **Home Screen** > **Change Wallpaper** > **Wallpaper and Graphics** > **Preloaded Wallpaper**, scroll to an image, press **Select**

The new wallpaper is applied to the current theme.

clock style

Change the clock style in the external display:

Find it:  >  **Settings** > **Home Screen** > **External Clock Style** > **Digital** or **Analog**

play music

To play music on your phone, you can use the native music player or the Rogers Music Player.

native music player

Find it:  >  Media > Media Finder > Music Library

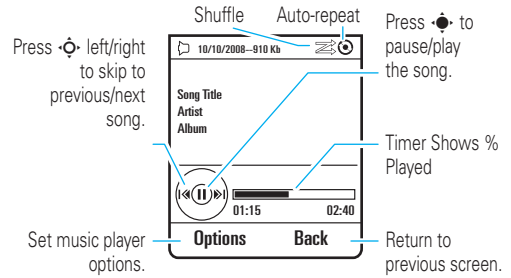

Select a song or playlist from these categories:

Recently Played, Shuffle Songs (play all songs in random order),

When a song is playing:



- **To control the music player**, press the **center key**  to play or pause  , press  left for previous , or press  right for next . Hold  left or right to rewind or fast forward.
- **To change the volume**, press the **volume keys** on the left side of your phone.
- **To minimize the music player** and leave the music playing, press . To reopen the minimized player, press  up and select the song again. To stop the music, press  twice.

2 Press  to call the contact.

Note: If you have contacts stored on your SIM card, but the contacts aren't visible when you open the contact list, you need to copy the contacts into phone memory. Press **Options** > **Import Contacts** > **SIM Card**, press **Options** > **Select All**, press **Import**.

messages

Here are a few messaging basics to get you started:

read & reply to a message in the external display

(Network/subscription dependent feature) When the phone flip is closed and you receive a message, your phone plays an alert, and the external display shows **New Message from X**, where **X** is the sender's number or name.

To read and reply to the message in the external display:

- 1** Press the volume keys on the side of your phone to scroll to **View**, then press the side select key to read the message.
- 2** When you finish reading the message, press the side select key to close it.
- 3** To answer the message, press the volume keys to scroll to **Quick Reply**, then press the side select key.

Rogers Music Player

Find it:  >  Rogers Music Player > song


To store **Rogers Music Player** files, use your computer to create a folder called “music” on your phone’s memory card (not under the “mobile” folder). Then, drag and drop music files from the computer into the “music” folder on the memory card.

create and play a playlist

To create a playlist on your phone:

Find it:  >  Media > Media Finder > Music Library > Playlists > Create New Playlist

Enter a playlist name, then select the playlist and select **Add Songs** to add songs.

To play a playlist, highlight it under **Playlists** and press the *center key*  twice.

battery conservation tips

Using certain features can quickly deplete your battery’s charge. **These features can include playing music or video clips, and using Bluetooth® wireless connections.**

You can conserve your battery’s charge by doing the following:

- Set your display to turn off sooner: Press  >  Settings > Phone Settings > Display Settings > Display Timeout > 5 Seconds.
- Turn off the internal display screensaver: Press  >  Settings > Phone Settings > Display Settings > Screensaver > Off.
- Turn off Bluetooth® power when not in use: Press  >  Settings > Connections > Bluetooth, press Options > Setup Bluetooth > Bluetooth Power > Off.

battery use & safety

IMPORTANT: HANDLE AND STORE BATTERIES PROPERLY TO AVOID INJURY OR DAMAGE. Most battery issues arise from improper handling of batteries, and particularly from the continued use of damaged batteries.

DON'Ts

- **Don't disassemble, crush, puncture, shred, or otherwise attempt to change the form of your battery.**
- **Don't let the phone or battery come in contact with water.** Water can get into the phone's circuits, leading to corrosion. If the phone and/or battery get wet, have them checked by your carrier or contact Motorola, even if they appear to be working properly.
- **Don't allow the battery to touch metal objects.** If metal objects, such as jewelry, stay in prolonged contact with the battery contact points, the battery could become very hot.
- **Don't place your battery near a heat source.** Excessive heat can damage the phone or the battery. High temperatures can cause the battery to swell, leak, or malfunction. Therefore:
- Do **not** dry a wet or damp battery with an appliance or heat source, such as a hair dryer or microwave oven.
- Avoid leaving your phone in your car in high temperatures.

DOs

- **Do avoid dropping the battery or phone.** Dropping these items, especially on a hard surface, can potentially cause damage.
- **Do contact your service provider or Motorola if your phone or battery has been damaged from dropping or high temperatures.**

IMPORTANT: USE MOTOROLA ORIGINAL PRODUCTS FOR QUALITY ASSURANCE AND SAFEGUARDS. To aid consumers in identifying authentic Motorola batteries from non-original or counterfeit batteries (that may not have adequate safety protection), Motorola provides holograms on its batteries. Consumers should confirm that any battery they purchase has a "Motorola Original" hologram.

Motorola recommends you always use Motorola-branded batteries and chargers. Motorola mobile devices are designed to work with Motorola batteries. If you see a message on your display such as **Invalid Battery** or **Unable to Charge**, take the following steps:

- Remove the battery and inspect it to confirm that it has a "Motorola Original" hologram;
- If there is no hologram, the battery is not a Motorola battery;
- If there is a hologram, replace the battery and retry charging it;
- If the message remains, contact a Motorola Authorized Service Center.

Important: Motorola's warranty does not cover damage to the phone caused by non-Motorola batteries and/or chargers.

Warning: Use of a non-Motorola battery or charger may present a risk of fire, explosion, leakage, or other hazard.

Specific Absorption Rate Data

This model wireless phone meets the government's requirements for exposure to radio waves.

Your wireless phone is a radio transmitter and receiver. It is designed and manufactured not to exceed limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission (FCC) of the U.S. Government and by the Canadian regulatory authorities. These limits are part of comprehensive guidelines and establish permitted levels of RF energy for the general population. The guidelines are based on standards that were developed by independent scientific organizations through periodic

and thorough evaluation of scientific studies. The standards include a substantial safety margin designed to assure the safety of all persons, regardless of age or health.

The exposure standard for wireless mobile phones employs a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by the FCC and by the Canadian regulatory authorities is 1.6 W/kg.¹ Tests for SAR are conducted using standard operating positions accepted by the FCC and by Industry Canada with the phone transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the phone while operating can be well below the maximum value. This is because the phone is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station, the lower the power output.

Before a phone model is available for sale to the public in the U.S. and Canada, it must be tested and certified to the FCC and Industry Canada that it does not exceed the limit established by each government for safe exposure. The tests are performed in positions and locations (e.g., at the ear and worn on the body) reported to the FCC and available for review by Industry Canada. The highest SAR value for this model phone when tested for use at the ear is 1.32 W/kg, and when worn on the body, as described in this user guide, is 0.8 W/kg. The SAR value for this product in its data transmission mode (body-worn use) is 0.31 W/kg. (Body-worn measurements differ among phone models, depending upon available accessories and regulatory requirements).²

While there may be differences between the SAR levels of various phones and at various positions, they all meet the governmental requirements for safe exposure. Please note that improvements to this product model could cause differences in the SAR value for later products; in all cases, products are designed to be within the guidelines.

Safety and General Information

This section contains important information on the safe and efficient operation of your mobile device. Read this information before using your mobile device.

Exposure to Radio Frequency (RF) Energy

Your mobile device contains a transmitter and receiver. When it is ON, it receives and transmits RF energy. When you communicate with your mobile device, the system handling your call controls the power level at which your mobile device transmits.

Your Motorola mobile device is designed to comply with local regulatory requirements in your country concerning exposure of human beings to RF energy.

Operational Precautions

For optimal mobile device performance, and to be sure that human exposure to RF energy does not exceed the guidelines set forth in the relevant standards, always follow these instructions and precautions.

Product Operation

When placing or receiving a phone call, hold your mobile device just like you would a landline phone.

If you wear the mobile device on your body, always place the mobile device in a Motorola-supplied or approved clip, holder, holster, case, or body harness. If you do not use a body-worn accessory supplied or approved by Motorola, keep the mobile device and its antenna at least 2.5 centimeters (1 inch) from your body when transmitting.

Using accessories not supplied or approved by Motorola may cause your mobile device to exceed RF energy exposure guidelines. For a list of Motorola-supplied or approved accessories, visit our Web site at www.motorola.com.

RF Energy Interference/Compatibility

Nearly every electronic device is subject to RF energy interference from external sources if inadequately shielded, designed, or otherwise configured for RF energy compatibility. In some circumstances your mobile device may cause interference with other devices.

Follow Instructions to Avoid Interference Problems

Turn off your mobile device in any location where posted notices instruct you to do so. In an aircraft, turn off your mobile device whenever instructed to do so by airline staff. If your mobile device offers an airplane mode or similar feature, consult airline staff about using it in flight.

Implantable Medical Devices

Potentially Explosive Atmospheres

- Limit the amount of time you use headsets or headphones at high volume.
- Avoid turning up the volume to block out noisy surroundings.
- Turn the volume down if you can't hear people speaking near you.

If you experience hearing discomfort, including the sensation of pressure or fullness in your ears, ringing in your ears, or muffled speech, you should stop listening to the device through your headset or headphones and have your hearing checked.

M-Ratings: Phones rated M3 or M4 meet FCC requirements and are likely to generate less interference to hearing devices than phones that are not labeled. M4 is the better/higher of the two ratings.

T-Ratings: Phones rated T3 or T4 meet FCC requirements and are likely to be more usable with a hearing device's telecoil ("T Switch" or "Telephone Switch") than unrated phones. T4 is the better/higher of the two ratings. (Note that not all hearing devices have telecoils in them.)

Hearing devices may also be measured for immunity to this type of interference. Your hearing device manufacturer or hearing health professional may help you find results for your hearing device. The more immune your hearing aid is, the less likely you are to experience interference noise from mobile phones.

- **Use your mobile device to call for help.** Dial 911 or other local emergency number in the case of fire, traffic accident, or medical emergencies.*
- **Use your mobile device to help others in emergencies.** If you see an auto accident, crime in progress, or other serious emergency where lives are in danger, call 911 or other local emergency number, as you would want others to do for you.*
- **Call roadside assistance or a special non-emergency wireless assistance number when necessary.** If you see a broken-down vehicle posing no serious hazard, a broken traffic signal, a minor traffic accident where no one appears injured, or a vehicle you know to be stolen, call roadside assistance or other special non-emergency wireless number.*
